NDIS | Revolutionising disability services

The Productivity Commission in its final report on the **National Disability Insurance Scheme (NDIS)** identified that ‘the disability support system overall is **Inequitable, Underfunded, Fragmented and Inefficient, and gives People with a Disability little choice**’.

On 20 October 2011, State and Territory governments agreed to deliver the foundational work for the NDIS by mid-2013 – a year earlier than the Productivity Commission recommended.

Our politicians are listening. But we still need to get out in the community, making sure everyone understands why people with a disability need an NDIS. We still need to keep the pressure on our politicians.

People with disability shouldn't just have an ‘**Eligibility**’ for services; they should have an ‘**Entitlement**’ to services. Your support can make a National Disability Insurance Scheme a reality.
